Tenderers are requested to visit the site personally, assess the quantum of work to be done and well acquainted him with the work and site situation and quote the rates accordingly.

A Tenderer can apply only One scheme form Sl. No.-01 to 06 individually.

The acceptance of the Tender will rest upon the authority inviting the tenders and does not bind himself to accept the lowest tender and reserves the right to accept or reject any or all of the tenders received without assigning any reason(s), whatsoever, and may split up the work, if necessary. The work should be completed within the stipulated period and proportionate progress should be achieved in the proportionate time. Under normal condition of time, the time will not be extended. Time may be extended for a very short period if progress of work hampered due to calamity and any such reasons. Payment of Bills after satisfactory progress of works will be made time to time as fund lying remains balanced.

In respect of the successful Tenderer who has deposited the 2% earnest money, another 8% of the tendered amount will be deducted from the progressive bill to achieve 10% security money. The successful tenderers will have to execute agreement with the undersigned within 7 days from the date of receipt of acceptance letter failing which the tender will be liable to cancellation without any reference.
